On August 4, 2021, Mayor John Cooper announced additional measures to protect public health. Due to the increase of the Delta variant, face coverings were required to be worn in all Metro Nashville Government buildings.

On-Site visits

Due to COVID-19, the Grand Jury was unable to conduct off-site visits. Due to this several MNPD units came to discuss specialize MNPD programs with the Grand Jury.

The following were presented:

A Crisis Intervention Team pilot program has been implemented. Metro Nashville Police Department and Mental Health Cooperative Specialist are trained paired together to de-escalated situations within the community during call-outs. This ride-along program is currently being piloted in the Hermitage and North precincts.

It was reported, Chief John Drake has implemented an Alternative Policing Strategies Juvenile Diversion. This program is being overseen by MNPD veteran, Terrence Graves. The department hopes to join forces with the Davidson County Juvenile Court, to decrease the current youth violence concerns. Also, a program similar to the Police Athletic League is in the development stages with the hopes to relaunch soon.

Concerns/Recommendations

During this jury term, a case was represented to the jury after a "no true bill" was granted. There was a reported concern by a juror, that this case could be represented to a new jury after a "no true bill" was granted on a previous jury.

A child's sexual abuse case was presented to the grand jury by an investigator from the DA's office. It was believed this case sat for several months due to the previous investigator not having enough evidence to process. However, once this case was presented there was clear evidence for an Indictment.

It is believed the youth violence in the Davidson County area has not improved. The Jury hopes the currently Alternative Police Strategies helps decrease these current concerns.

The cases being heard are traumatizing and at times difficult to process. Remind jurors of this and provide mental health resources.

Final Thoughts and appreciation

We found this experience of serving on the Grand Jury to rewarding. It was our pleasure to serve with a group of individuals from various backgrounds and skills sets.

The Grand Jury would like to take this opportunity to extend a sincere thank you to Judge Cheryl A. Blackburn, Judicial Assistant April Lee for allowing us this opportunity.

Officer Mike Fisher is an excellent representative of the MNPD. His expertise as an officer and MNPD policies was helpful and informative. We thank Officer Fisher as well as Officer Nathaniel Ellsworth.

We would also like to thank all the frontline workers that are working hard to bring all the cases to justice.

Finally, The District Attorney General's Office of their ongoing will to answer the grand jury's questions and provide adequate literacy that supported answers.
