Attorneys, please let your clients know that they need to arrive to Court early to ensure they are on time. Additionally, please inform them of both the parking logistics at the courthouse and the security process upon entering the building. This is to ensure smooth and timely hearings. Your client's case may be the first or only case heard by the Court, despite what the docket might reflect. If you or your client are expecting to run late, please call the Court at (615) 862–5910 to inform a staff member of the timing.



Pending Cases

Chamber Rule Spotlight: General Requirements for Pleadings

Rule VI.6&7, Page 9: Signature Blocks and Certificates of Service

— 6. Signature Blocks ————

"All pleadings shall include a signature block for the attorney or self-represented litigant filing the pleading. The signature block shall include:"

- Name of the person filing the pleading
- Party the attorney represents (if applicable)

7. Certificate of Service -

"With the exception of pleadings that are served via summons, all pleadings shall include a certification that the pleading has been served on the opposing party. The certification shall include:"

- The date of service
- The method of service
- The address, fax number, or email address where the pleading was served
- Signature of the attorney or self-represented litigant serving the pleading






