Judge Smith served as the Judge of the Fourth Circuit Court from 2009 until his unexpected passing on September 4, 2022, days after being re-elected to a third



Judge Smith graduated from the University of Tennessee College of Law and became a licensed attorney in 1988. He started his legal career working with the Davidson County Office of the District Attorney General. He left the District Attorney's office in 1990 and spent the next 19 years in private practice, with a primary focus in family law. His years of practice garnered recognition in Best Lawyers in America and Mid-South Super Lawyers and admission as a Fellow to the prestigious American Academy of Matrimonial Lawyers in 2009, among other accolades.

In March of 2009, Judge Smith was appointed to the Fourth Circuit Court by then Governor Phil Bredesen. He was re-elected in 2010, 2014, and 2022. He was one of two judges in Nashville who presided over family law, divorce, and domestic issues. During his time as Judge, he taught Family Law and Domestic Trial Practice at Nashville School of Law.

Hard-working, compassionate, and highly knowledgeable in domestic law, Judge Smith had a passion for fighting against domestic violence. In 2010, he worked alongside Jean Crowe to encourage Mayor Karl Dean to conduct a safety assessment of the domestic violence prevention procedures in Davidson County. These requests led to the Nashville-Davidson County Domestic Violence Safety and Accountability Assessment released in 2013, which resulted in many changes and improvements in the prevention of domestic violence, including the creation of the Jean Crowe Advocacy Center and the Family Safety Center. Judge Smith also served on the board of the Family Safety Center. This week will mark a "Decade of Progress" for this collaborative effort as the release of Nashville's 10-Year Interpersonal Violence Progress Report takes place. This report



honors the legacy of both the late Attorney Jean Crowe and Judge Smith. A copy of the report can be found **HERE**.

#### ORDER SETTING STATUS CONFERENCE

At the beginning of this year, we had nearly 2,800 pending cases in our Court, many of which had been sitting dormant for years without any activity or filed final order. **As of July 31, 2025, the number of active cases pending in the our Court is 1,259.** This is the result of the diligent efforts of the Fourth Circuit Team to personally review each pending case file to ascertain whether it is timely progressing, should be dismissed, or should be set on a status conference docket. The status conference orders are drafted and mailed to the last attorney of record, or litigants if self represented.

The purpose of these status conferences is to give attorneys and litigants an opportunity to come before the Court to discuss the status of each case including steps needed to dismiss or nonsuit the case or initiate movement so that the case may be properly resolved. **Ahead of the conference**, please review your own files and bring such information that may not be reflected in the Court's record.

Attendance is required as it allows all parties and counsel for parties an equal opportunity to discuss the status of the case as well as appropriate steps forward. However, should the petitioner wish to dismiss and/or nonsuit the case, attorney for the petitioner, or the petitioner if self-represented, may email the Court at ronnellgriffin@jisnashville.gov and include the opposing counsel, or opposing party if self-represented. Please be sure to also include the docket number, intention to dismiss or nonsuit the case, and any other relevant information the Court needs to know. In this instance, the Court may inform you that attendance is not required at the status conference.



Please remember that the option to appear via Zoom is available for every status conference docket. The Zoom link is the same the link to our regular Friday motion docket and is included in every order. You may also scan the QR code to the left to join.

## **RULE XX, PAGE 36: INTERPRETERS**

In the event an interpreter is necessary for any hearing in the Fourth Circuit Court, the use of the State Trial Court interpreter, an interpreter approved by the Administrative Office of the Court (AOC), or an interpreter approved by the AOC guidelines, is required. It is incumbent on the party requiring the interpreter to secure the same. 
