MINIMIZING HIGH CONFLICT IMPACTS

As conversations about the impacts of high conflict cases are becoming more common, so are solutions. Attorneys play a crucial role in these cases and influence their clients greatly, potentially changing the long-term outcomes for parents and children. Collaborative Divorce

Collaborative Divorce Nashville is Nashville and Middle Tennessee's practice group for the collaborative divorce process. The group consists of practitioners who are specially trained in the collaborative divorce process, regularly obtaining continuing education in this area.

The collaborative process is a private way to resolve disputes without fighting in court. As in many divorces, each spouse has their own lawyer to provide legal advice specific to each spouse's needs. What sets a collaborative divorce apart, however, is the addition of both mental health and financial professionals providing the spouses with emotional and financial support. These neutral professionals work with both parties to help prioritize goals, make the process more efficient and more likely to result in a mutually beneficial agreement that stands the test of time.

CHAMBER RULE SPOTLIGHT

RULE XIII (E), PAGE 29: COURT REPORTER REQUIRED


- **1.** Absent leave of the Court, for good cause shown, a court reporter is required for all contested final hearings. Unless otherwise agreed upon by the parties or ordered by the Court, the parties shall be equally responsible for the *per diem* of the court reporter.
- 2. In cases involving an indigent party or parties where a court reporter must be hired with the approval of the Tennessee Administrative Office of the Courts, all motions for such approval must be filed contemporaneously with a Motion to Set.
