Retired Circuit Court Judge of the 21st Judicial District of Tennessee

In 2014, Robbie Beal returned to private practice after serving a seven-year term as Juvenile Court Referee/Magistrate, followed by an eight-year term as Circuit Court Judge for the 21st Judicial District (Williamson, Hickman, Lewis and Perry counties). Donald Harvey, Ph.D., LPC-MHSP is professor of graduate counseling. While at Trevecca, he established the master's degree program in Marriage and Family Therapy and co-created the CACREP Accredited Ph.D. program in clinical counseling, teaching and supervision. He has authored 10 books on counseling related topics, practiced as a therapist in multiple clinical settings, supervised developing therapists in agency, academic, and licensure seeking settings and spoken extensively in national conferences. With a specialization in couple's work,

Donald's doctorate is in marriage and family therapy from Virginia Tech and he is an AAMFT Clinical Fellow and Approved Supervisor. Along with wife, Jan, who is also a therapist, he has worked extensively with intensive psychotherapy experiences for clergy couples in crisis. Being a strong proponent of therapist self-care, Donald is an active fisherman and states, "alternative passions do not compete with a therapist's professional life but actually compliment it--alternative passions are necessary to bring balance and prevent burnout."

Her focus at Trevecca is on the mentoring and development of counselors, supervisors, and educators, and her desire to serve her students' pursuits of counselor identity has deepened through her work as dissertation chair over the past 15 years. Dr. Lahey's research interests involve, but are not limited to, clinical supervision, counselor educator training, marital crisis, family cohesion and leadership skills. Kristen Menke serves as Special Master for the Fourth Circuit Court for Davidson County, Tennessee. Special Master Menke has served in this capacity since her appointment by Judge Stanley A. Kweller in April 2023. She received her undergraduate degree from The University of Tennessee in 1999 and her Juris Doctor from The University of Memphis Cecil C. Humphreys School of Law in 2005. After graduating law school, she clerked for Judge Thomas T. Woodall, Tennessee Court of Criminal Appeals. In 2007, she was hired by District Attorney General Victor S.

Johnson, III, 20th Judicial District, and served as an Assistant District Attorney prosecuting crimes against children until entering private practice in 2014. Special Master Menke's private practice included family law and criminal defense.

Stephanie J. WilliamsJudge of the 4th Circuit Court of Davidson County

Stephanie J. Williams, originally from Louisville, Kentucky, has called Nashville home for more than thirty years. She earned her B.A. in Management and Human Relations from Trevecca Nazarene University and her law degree from the University of Tennessee College of Law, later completing graduate coursework in Marriage and Family Therapy.

Her legal career began at Manson, Jones & Associates, where she practiced in a variety of areas before focusing on family law. In 2006, she founded the Family Justice Center, providing reduced-fee family law services to low-income families. She later launched her own practice, SJW Family Law, continuing her mission of making quality representation accessible. In 2014, she was appointed Special Master of the Fourth Circuit Court, a position she held until 2022. In September 2024, Judge Williams began her elected term as Judge of the Fourth Circuit Court, which hears family law matters exclusively. Beyond the bench, she teaches at the Nashville School of Law, mentors future lawyers, and is active in numerous civic and professional organizations, reflecting her deep commitment to both the legal community and the families she serves.

CASE STUDY

Diane has sought help after confiding in a friend who recommended your services.

Diane (35yo) has been married to Jack (37yo) for 13 years, and they have two children together, Jan (9yo) and Greg (6yo). In your introductory meeting with Diane, you discover that she is seeking your help as she and Jack are headed for divorce. Jack moved out of the family home five months ago and is renting an apartment nearby so he can remain involved in the children's lives. Financially, Jack has been the primary earner, while Diane has worked part-time jobs so she can prioritize her schedule around the children's school and social activities. Diane reported that at first, she and Jack tried amicably to work out the divorce details. The couple's inability to come to agreement with respect to the division of assets and debts, spousal support going forward, and co-parenting has left Diane weary. Diane communicated that the tension between her and Jack has become unmanageable and often boils over into emotion-packed conflict, often occurring when the children are present. She confided that she's noticed that Greg is more withdrawn and often has an emotional outburst just prior to when Jack picks him up to take him to soccer practice. Diane also shared that Jack recently said to her that, "when I try to talk to Jan, it's like I'm talking to a younger version of you." Diane acknowledged that sometimes Jan sees her crying after an argument with Jack.

Through the course of the conversation, you confirm there are no concerns about extramarital affairs, addictions or disorders, or secret-keeping, financial or otherwise.

Please respond to the following:

- 1. From your discipline's perspective (attorney or counselor), share what you identify as the critical details in the case study.
- **2.** From an attorney's perspective, share with the counselor(s) when you might consider referring your client to seek counseling. Solicit feedback on the timing from the counselor's perspective.
- **3.** From a counselor's perspective, share with the attorney(s) when you might consider referring your client to seek legal counsel. Solicit feedback on the timing from the attorney's perspective.
- **4.** Working together as attorneys and counselors both tasked with operating in the best interests of your client, develop recommendations on how to best support your client and operate in the best interests of the child(ren).




